With the Zeppelin to South America: Diary of the Round Trip 1931

Around 2000 the Frost Publishing Co. purchased, at auction, the diaries and photographs of Carl Bruer, a *Graf Zeppelin* passenger of the 1930s. In 2002 they published the previously unpublished material of his October, 1931 flight to Pernambuco, a city on the eastern tip of Brazil.

This book would make a welcome addition to the library of the Zeppelin enthusiast. Aero historians are already familiar with the stamps, rates, and routes of the Zepps and others. Bruer contributes a detailed daily journal of passenger life aboard the *Graf Zeppelin* and of what was awaiting for them in Brazil on their four day stop.

The flight is well described from the air station at Friedrichshafen through the terminal in Brazil. Even in 1931 they had a Zeppelin museum at the air station. He describes how the wind speeds can adjust the trip making it a day longer or shorter. The daily life on the 3-4 day trip was always filled with sights, conversation, good food and spirits, and more.

Along with the text are 40 of Bauer's aerial photos of the coastline, cloud cover, passenger ships, islands and others along with snaps of Pernambuco and environs. There they went on sight-seeing tours and excursions of the beaches, remote villages, historical sites, and many others. The book also contains almost 200 nearly full-size pictorial and slogan cancels of the *Graf Zeppelin* South American flights.


Of course, there will be more auctions, a summer picnic, and dinner banquet again this year.

### The State of the Philatelic Hobby

As seen from across the ocean

In his Market Tipster column in the December ('08) *Stamp Magazine* (pg. 30), Phil Atlee gives his opinion on the health of the stamp market from his viewpoint in the UK.

The hobby is in a current economic crisis, but this is true with most collectibles—such as coins, trains, and others. The internet has had an impact, but the credit crunch remains with fear of uncertainty and the tendency to spend on staples.

The shows are a little less

crowded, but sales revenues are stable making dealers pleased.

Early retirees are returning to their childhood hobby and are purchasing material that is likely to hold its value while avoiding new issues and overpriced products such as presentation packs, bundled products with coins, and other gimmicky marketed stuff.

The demand for revenues is insatiable, and many are seeking pre 1970s errors with varieties in shade, watermark, and/or

perforation. Proofs, essays, Cinderellas, and poster stamps are also becoming highly collectible.

Collectors' kids, in general, are less interested in the hobby, so the material is placed on the market. The higher quality collections are bought up. But those items that were collected especially for the children such as First Day Covers and commemorative packs are very hard to unload, as the dealers can't sell them. There is no market.

# Marilyn Shirley wins PSLC Lifetime Achievement Award

At the 2008 PSLC banquet in December beloved member Marilyn Shirley was awarded the club's Lifetime Achievement Award. She has done so much over the years for the club.

Marilyn served as club president, and she edited the newsletter for years. In this she wrote the news, typed the pages, mimeographed them all, collated them, addressed them, franked them, and mailed them. Through this she gives much credit to her son and club member Mike, who helped her with the newsletter over the years.

For a long time the club had an active program for youth. In support of this, Marilyn held a weekly summer stamp camp for them at her home. They worked on their collections in the morning and swam in the afternoon.

This August will be the first in a long time that Marilyn and Chuck are not hosting the club picnic at their house with the family grilling the chicken and corn on the cob for all. And a ditto can be said for the annual Christmas dinner that she has organized forever. We are now holding this at our new meeting site at Wood Crest Villa.

Through the mentorship of a charter member of the club in the 1960's Marilyn and her sister began to collect stamps. They were given an album to start with and introduced them to the club. She says that she "collects everything," and she is currently working on Great Britain and the colonies which she reports are quite a challenge. She meets regularly to collect and trade with her sister in law, Mary Husson. To round out the family ties to philately, her granddaughter, Diedra is a collector.

Marilyn is a 25 year retiree from Millersville where she worked as secretary to

the dean and to the Admissions Department. The members of the club are deeply indebted to Marilyn Shirley and all she has done.





In the recent 15 December issue of *Linn's Stamp News* was a short article of a philatelic robbery where the front door was smashed in and the entire safe taken. This collector had a safe and all, but was there even more that he could have done for protection?

There are steps we can take to protect our collections from theft and damage, and I wrote about some of them in the October 2008 newsletter. But these events are not as common as the problems our heirs face when we go over to the other side and leave them our treasures.

A philatelic inheritance can range from an accumulation in a box, or even worse, several boxes to an organized collection with valuation and instructions, in writing for the disposition of the material.

In my first "Musings..." as editor last January, I opined about New Year's resolutions, particularly philatelic resolutions. As

such, I am getting on the soap box again this January, to encourage you to do some estate planning for your collection. If you have a nice album or two that the kids or grandkids really want to have, there is not much you have to do except to decide who gets what. Put it in writing and/or make other arrangements so that your wishes are carried

On the other hand, if you are one who has a "stamp room," then you have your work cut out for you. Are you a dealer? Then you have a whole load of things to do which may run the gamut from business to legal issues.

As my cynical attorney friend once said to me, "It is much easier to plan your estate when you are alive than after your gone." And there is an element of truth to this. Once you are gone, you have no say in what happens to your stamps and covers.

My grandfather was a parttime stamp dealer with an office at 66 Beaver Street in Brooklyn. He died very suddenly and unexpectedly at 47 in 1936. Need I say more. It was a mess.

I recall my mother stating how her uncle cherry picked the best stuff that was to go to her as her dad's only heir, but she was young and inexperienced in this sort of thing. Her parents were divorced. Who at 21 doesn't think that their family will protect their interests? Unfortunately, she was very wrong.

A while back my wife related to me that my father, who was a quasi stamp collector in his own right, once told her that he heard that my grandfather had owned an inverted Jenny. After all, he lived at the right time and place and was an airmail specialist. Could this be true? I think not; it is proba-

bly an urban legend. But it is fun to think about. Regardless, there isn't one now!

The long and short of this is that you don't always have advance warning when your time has come. When making plans for your collection, your treasures, it is better to do it sooner than later.

The recent Marist College poll identified that 60% of the sample believe that they will not follow up with their New Year's resolutions. Let us do otherwise! It is January, the time to make the resolutions of the New Year. Make them now, and start to carry them out ASAP.

Last summer I attended a short estate planning seminar at APS and learned some ways to insure that collectors' wishes are carried out concerning their holdings. I will offer some of these recommendations in the February or other 2009 PSLC newsletter.
