The rules remain the same as in previous auctions. • The minimum bid is \$1.00. ● The minimum increment when bidding is 50¢. ● Each club member is limited to 10 lots. • You will be assigned a number when you arrive. Please place this number on all your lots. Attach an item/lot description including catalogue number, value if appropriate, and minimum bid accepted. This will speed things up a great deal. • Fiscal transactions will only take place after the last item has been sold. Further, the auction committee recommends the following: • Bring cash whenever possible to pay for the items you win and • Keep a running total of items you have won and sold based on the prices realized. • Finally, be sure to firmly attach your sales information (lot description, cat. value, min. bid etc.) to the item. This will insure that items are represented accurately.

**Opening:** Treasurer Lou DiFelice opened the meeting at 7:05 PM.

**Dues:** Membership chair Lucy Eyster announced that 2011 dues are outstanding for only four stamp club members.

Membership: Roy Baardsen announced that Lancaster and Reading club member, Carl Waller passed away on 9 April. Paul Petersen read an email that he received from club member Herb Tindall in Honey Brook stating that it was his wife Dorothy and not him (Herb) that passed away. In this communication, Herb cited Mark Twain's famous line: "Reports of my death are greatly exaggerated." He added that at 96 he continues to do well and plans to remain a PSLC member as long as he is around.

**Drawing:** Al Schaub donated four packets of Bermuda stamps for this month's drawing.

**Programs:** Paul announced that members may sign up for presentations for next year. Help is available with PowerPoint if desired. He further said that presenters, if they like, may submit a short article for the newsletter regarding their topic, but this is purely optional.

Lancopex: Jim Boyles recirculated the sign-up sheets for Lancopex along with the patron list for those interested. There are still many openings on the work schedule for the show which need to be filled. Lucy added that the snack table is well staffed and ready. Paul noted that the church youth group is on

board for frame transport and assembly. He also passed around the menu that will be available for dealers and club volunteers for lunch on both days of the show.

**Q&A:** Vern Marten asked about the validity of using "Forever" or other non-denominated stamps on mail to Europe. **A:** These stamps are only good for domestic use, as postage to points outside the U.S must have a denomination printed on them.

## Lancopex-2011: What our dealers said

Dealer feedback is an important management tool for continued improvement of our show. As in past years, the dealers were quite positive about the '11 event. Out of 20 dealers, 18 returned completed surveys (90%).

Regarding their financial goals for the show, two (10%) did not meet their goals while three were 50-50 on this item. Seventy-five percent (15) met their goals.

The switch from a Sat/Sun format to Fri/Sat was also

seen as a positive move. Fifteen (75%) dealers supported it; two (10%) were negative, and three did not care (15%). One dealer remarked that if it went back to Sat/Sun, he would not return. Another noted that he had to take Friday off from work, but this was OK.

An important metric is the rating from 1-10 (low-high) how dealers compare our show to others of a similar venue. The average was 8.75 with a range from seven to

ten. This is up from 8.62 in '10 and down from 8.83 in '09.

Open ended questions followed. For positives, five cited a good sized crowd while two added that they were "nice collectors." Six dealers identified club member support and friendliness. Two more gave kudos to the club as a whole while two viewed the Lancaster venue as a plus. One noted that loading and unlading was convenient, while another found the fine exhibits to be a draw. A master textile designer, Carl owned a mill in West Lawn in addition to a long resume of fabric development achievements during his professional career.



#### American Topical Association Admits PSLC

It was announced in the March-April Issue of Topical Time that PSLC has been admitted as ATA's newest chapter (#118). Our club meeting times & location were included along with a half page discussion of recent club events. This may attract new PSLC members.

(**Dealers**) mentioned lunch and snacks. One dealer liked the distance between tables, while another liked serving his PA customers.

Opportunities for improvement: Three dealers recommended a change in door prizes. Instead of donations that the winner may not want, give them a \$5 credit that can be redeemed that day with any dealer who would be reimbursed by the club.

Other recommendations in-

cluded some help for loading and unloading; electric outlets for tables in the center of the room; hotel discounts; and two would like an additional table.

Two dealers recommended that their locations in the Farm & Home Center not be changed to make it easier for customers to find them. One dealer noted that he has been in four locations in the last four years. Finally, a dealer (and several club members) noted smudged cancels on the show cachets.



A lot of energy in the hobby goes to crabbing and bellyaching. Folks gripe about the number, quality, or subject matter of U.S. stamps. Others complain about their own collection and what they will never own. Some decry the decline of the hobby with all the gray-haired collectors, along with the demise of the stamp show in favor of the internet. I know that I have fallen prey to some of the above, but heck, isn't it every stamp collector's God-given right to gripe about something if they want to?

So I found a little solace in the April issue of **The American Stamp Dealer & Collector** (pgs. 5,6) from the "Moving Forward" and "First Word" columns of ASDA president James E. Lee, and *ASD&C* editor, Randy L. Neil respectively. This publication is one of my favorite stamp collecting journals.

I saw the recent magazine cover as pictured and looked with awe at the 1d and 2d Mauritius Post Office issues. (I figured that they were having a contest with the winner taking the "Post Office" stamps home.)

Dealer Jim Lee challenged the notion that the stamp show is slowing down in favor of the internet. He has observed that many of the recent shows he has been to were like the golden years of the 1980s. He posited that this venue will never go away, and gave two reasons for this.

The first reason is people. As human beings we desire to be with others, especially other stamp collectors

who share our philatelic interests. At a show we can run into old friends and meet new ones.

Lee adds that the other importance of the stamp show is the opportunity to touch, hold, and examine with the naked eye. It is a tactile hobby. There are many beautiful images of postage stamps, but there is nothing like the real thing in our hands/tongs.

Randy Neil's column countered the concern that some express when looking around and seeing only older collectors. They wonder how the hobby can survive. To highlight this, Randy cited a letter to Mekeels's Weekly Stamp News. Here a collector griped in dismay that two-thirds of his stamp club were at least 60 years or older. He experienced the same with participants at stamp shows. He wondered if there would be anyone to buy his collection. This article appeared in 1917! So then as now, the hobby appeals to all ages, but most specifically, those past 50.

Randy is also impressed with the burgeoning of interest among young people, and he attributes this to us "oldsters" making it happen. But I still have concerns.

At APS '10 Summer Session John Hotchner asked a room of about 60 people if they collected as kids. Now it must be said that this audience is made up of the fundamentalists of the hobby.


Yet, it turned out that all but two were childhood collectors.

I am enough of a researcher to know that what I am about to offer is pure speculation, but let me try. Let's say that I went to a mall and surveyed 1000 middle-age and above adults. 1. Did they collect as a youth? and 2. Do they collect now? I would guess that there would only be a few collectors. But more important, I would also speculate that of those who do not collect now, very few of them collected as kids.

Most of us graying hobbyists who collected as kids had several stamp friends growing up. So for the few new collectors who started as adults, they probably had friends or family members to observe as they grew up or they know current collectors. This gives an inkling of what the hobby is about.

So today's mature collector had either personally collected or knew someone who collected. Will the next generation of collectors be so fortunate to grow up with family and/or friends as collectors? I wonder.

Previously I noted that I met young children who have never seen stamps! They came up to me when I was sorting stamps in a local café. So, in one man's opinion, this is the issue. Will future collectors engage in a hobby of which they have no history of personal collecting or exposure to other collectors?



I have heard the terms: "reviving the hobby...reviving collectors." In the true sense of revival, there has to be something to revive. One can revive a fire in the hearth only if there are a few sparks or embers. If the ashes are cold and dead, the fire cannot be revived.

Think of the potential collector with a history of childhood experience, either collecting directly or observing others. This individual's collecting can be revived. But without some history, or spark in those ashes, the likelihood of taking up collecting is greatly diminished.

It is so important for our club to facilitate youth philately along with the 50 plus generation. Should we sponsor a junior club? Any ideas?
