If there's any question about the availability of deceased persons worthy of note, a look at this year's calendar of planned new issues shows a total of thirty such commems. They include John H. Johnson, Danny Thomas, Jose Ferrer, William H. Johnson, ten poets, four film directors, Miles Davis, Edith Piaf, four baseball stars, four choreographers, Edgar Rice Burroughs, and O. Henry with the possibility of one or two yet to be determined. Along with all the others scheduled for this year, I think we have enough to keep us going to the post office.

For many years I have been a member of the Universal Ship Cancellation Society. My interest goes back to WWII when my dad served as a radar technician on the destroyer, the U.S.S. Waldron, in the Pacific. I've never formed a special collection but have accumulated many covers from ships that served in that war. The USCS was formed in 1932 and promotes the study of the history of ships and their postal markings. Its services include a monthly journal (USCS Log), an annual convention (at Balpex next year), monthly auctions, a great variety of publications, regional subgroups, and more. Len Kasper

2012 USPS Plan to Announce New Issues PSLC Members Are Noticing the Difference

In his U.S. Stamp News column (Sept.-2011, Pg. 32,) publisher John Dunn discussed the new USPS policy for announcing new stamp issues. Announcements had previously been en masse, usually in the fall, but for the 2012 issues, USPS has been sharing the news issue by issue, what Dunn calls a rolling rollout. The reason for this has been that many of the stamp themes and images had been leaked to the philatelic press, resulting in some errors. Further, these unofficial announcements to both the public and collectors alike got the scoop over the USPS.



While the new policy has some advantages, there has been some conflicting information between that in the PR releases (USPS and philatelic pubs alike) and reality. Inquiring PSLC members have noticed this.

This was apparent with the First Day release information for the \$1.05 Lancaster Int'l airmail stamp issued on 20 January. Dick Colberg's ordeal with USPS was described here last month.

In early February **Dave Hunt** thought he might have something with the 2012 Love stamp. This was listed as having a 14 February first day of issue. While at the Bowmansville (PA) PO on 6 February, he noticed that the Love stamp had just gone on sale. This was eight days early! Might this be an EKU (earliest know use) of the Love stamp?



Dave immediately got some covers, franked them, and had them serviced. His research revealed that there was a miscalculation at USPS. The Love stamp has always been issued <u>before</u> Valentine's Day so that it could be used on cards for mailing prior to the occasion. After all, isn't this one major purpose of the Love stamps? To fix the problem, USPS notified postmasters that they were allowed to sell the Love stamps as soon as they arrived.

While Dave may or may not have an EKU of this stamp, he knows that it is the earliest date of release at the Bowmansville PO because they arrived the day he was there.

Rob Rothen, too, reported a disparity with his order of the presorted first class coil Spectrum Eagles from Kansas City about the time of their 3 January release. (See illustration below of these stamps in *USA Philatelic*, the marketing magazine of USPS.)



The advertised illustration pictures the stamps touching at their vertical die cuts. To Bob's surprise, his order arrived in a different arrangement. The stamps were not touching, but instead, they were separated by a millimeter or so.

Like Dave, Bob did his research and contacted the editor at *Linn's* who gave him a preliminary opinion but referred it to the new issue specialist who concurred with him. It seems that changes in the format were made between the time of the initial publicity image and the subsequent stamp release date.



Bob commented later about what he read in Linn's regarding the 2012 Love stamp. This stated that USPS allowed the stamp to be sold much earlier than the "official" release date of 14 February. However the first day cover from Kansas City would still be 14 February. Bob recommends keeping a set of the unofficial (2-13 Feb or earlier) and official (14 Feb) covers, believing that future collectors of modern U.S. postal history will have some fun with the various EKU and FDC cancellation dates.



Ave Et Vale: The PSLC extends its sympathies to the families of member Robert Krouse of Willow Valley and former member and stamp dealer Roger Gratz of E-town who passed away on 10 and 12 February 2012 respectively.





Regarding the interesting looking stamp included with Dr. Allen's biography in this newsletter last month (See #428 below), it's a 1990 Guernsey 50th Anniversary stamp of the German Occupation of the Channel Islands (30 June 1940 to 8 May 1945).



Guernsey's supply of 1d stamps ran out, so the GPO let customers diagonally bisect the 2d stamps. The orange 1937 GRVI 2d stamp was bisected (Scott#238) as seen below:



A bisect of the 1940 GRVI-Queen Victoria Penny Black Centenary stamp (#255) is seen below.



As these two stamps ran short, collectors brought out their holdings of the 1912-1924 GRV stamps which they also bisected and posted.

Musings: March-2012

In 1940 Guernsey printed three wartime denominations (Scott# N1-N5: The N4-5 stamps were similar face issues to N1-3 but on different paper). These stamps were valid through 13 April 1946.

Below is an image of Guernsey N-1 on the 1991 Scott 446, a 50th Anniversary commemorative of the 1941 issue during German occupation.



On Jersey, there was a different twist. One of the German occupiers was also an ardent stamp collector, and he took many philatelic liberties. He and others sent a variety of interesting covers back to Germany.

There are extant covers with mixed franking of German and Jersey stamps. The German stamps were cancelled with Feldpost strikes, while those of Jersey were cancelled with Jersey strikes.

Channel Islands postage during German occupation

Jersey printed two sets of wartime issues, the first 1941 set (N1-N2) was similar to those of Guernsey, and the second in this series, N2 is depicted below.



In 1991 Jersey issued a 50th Anniversary stamp of its first postage stamp that they issued under German occupation. (see #563 below)



From 1 to 29 June 1943 Jersey issued a second set of six stamps (N3-N8, The Jersey Landscape Series) which were also valid through 4/1946. Depicted below is N8, "Gathering Seaweed."



Of interest is the set of six stamps issued in Guernsey on 9 August 2011. They are based on the best-selling novel, The Guernsey Literarv & Potato Peel Pie Society which was reviewed in the 12/08 issue of this newsletter. It is historical fiction of the German occupation of Guernsey, perhaps the most traumatic time in modern history for these Island people. There is talk of a 2013 Hollywood movie based on this 2008 novel. Two of these stamps are seen below.
