Slender You Tanning of Leola

The traffic light at Route 23 and Route 772 (east) in Leola offers a view of two very different businesses. If you look south of the intersection, there is a Giant grocery store with a large parking lot and all the modern conveniences. If you look north of the intersection, there is an old two story stone veneered building that houses a tanning salon. The old building was much more than a tanning salon in its day, including being a grocery store. This article will attempt to identify some of the highlights in the life of one of Upper Leacock Township's most historic buildings.

According to local histories, Samuel Garber built a private residence on this site in 1800. Samuel's grandfather, John Garber, was granted the first deed to the land in 1745. It was transferred to Samuel's father, Michael Garber, in 1769. When the property was conveyed to Samuel Garber in 1813, his occupation on the deed was listed as "innkeeper", so it's likely he converted his residence to a tavern prior to that date. By the time Samuel Garber died in the 1830's, Frederick Swope had built an addition that provided space for a store on the west side. Swope purchased the property in 1838.

During the 1840's, the "public house of Frederick Swope" was a favorite meeting place for all kinds of groups, including the Anti-Masonic Republicans, School Directors, and the New Holland Turnpike Company. The Turnpike Co. used this venue well into the 20th century because it was the midpoint between Lancaster and Blue Ball. On June 1, 1842, a meeting was held here to discuss the division of Leacock Township because it was 16 miles from tip to tip, and too far for many to travel for Township meetings. Almost exactly one year later, Upper Leacock Township was formed. The first elections for the Township were held in this building. Frederick Swope was appointed Postmaster, so the post office was located here. In 1850, Swope left the management of the businesses to Michael Bender, and partnered with his son at a local saw mill. He didn't have as much success there, and lost four fingers to a circular saw in 1852!

The estate of Frederick Swope sold the property to Michael Bender in 1854. After Bender's death, title to the real estate went to Abraham Kachel, then Marks Wenger. During Wenger's tenure of ownership, Jacob Bard was the proprietor of the Spread Eagle Hotel on the eastern side of the building. In 1874, Wenger sold it to Michael Dissinger, who managed the hotel and livery stable, and rented the store on the west side. Hiram D. Bucks, who was related to Frederick Swope through marriage, began running the store during the 1880's. While Dissinger owned the property, its address went through a transition. The 1896 Lancaster County Directory listed Dissinger as proprietor of the hotel in Glenola. The name was short lived because the railroad would not allow it. There were already stops on the line named "Glenora" and "Glenolden", so the "G" and the "N" were removed...thus was born "Leola".

In 1901, Michael Dissinger sold the landmark to George H. Shreiner, who owned it for only four years. During his tenure, Bucks operated the store and J. G. Witmer was proprietor of the hotel. B. F. Weidler bought the property in 1905, but managed the hotel for only three years before conveying the business to his brother, George Weidler. Up to this time, when the property changed hands, the new owner was most interested in the tavern and hotel business. However, as the demand declined for the hotel, the store was holding its own.

Real photo postcard circa 1913 showing signs for "P. H. Meckley Cash Store" on left and the "Spread Eagle Hotel" on right. Meckley bought the store business from Hiram D. Bucks. The old landmark was located near the eastern edge of Mechanicsburg and the western edge of Leola.

In 1920, the estate of B. F. Weidler sold the property to Nathan W. Bard, who began managing the general store in 1916. Harry L. Miller purchased it in 1940 after Bard went bankrupt. Miller was a staple for almost 40 years before selling to John and Virginia Fuller in 1980. Soon after, they opened "Leola Fireplace and Stove Shop". Several years later, they opened "Slender You Toning" in the building. By 1990, the commercial enterprises were called "Slender You Tanning Salon" and "Leola Heating Center", and were owned and operated by Virginia Fuller. Virginia died in 2015, and the property and businesses were left to her daughter and husband, Sharon and James Murphy.

He moved to Brownstown in 1920 and was killed in 1932 when he crash landed his Fairchild Model 22 (Lancaster Airport's first fatal accident).
